Sen. Zell Miller of Georgia wrote a book titled *Everything You Need to Know, I Learned in the Marines*. I believe this book has some application for newly licensed attorneys. In 1883, the Marine Corps adopted the motto *Semper Fi*, which is short for *semper fidelis*, a Latin phrase meaning “always faithful.” It is significant because there are no ex-Marines, only former Marines. A Marine is called on to be always faithful to Country, God, Corps, and Family. Likewise, you never hear someone say that an individual *was* an attorney, or someone *used to be* a lawyer. When we take this oath today, we become attorneys for life. And that is something people will always say about you — your family and your friends will say you are a lawyer and they will look to you for advice.

Therefore, the question becomes, “To what will you be *semper fidelis*? To what will you be always faithful? And as we have
